### EXECUTIVE ORDER APPROVAL ON EASE OF DOING BUSINESS WAIVERS IN JIGAWA STATE

WHERAS The Government of Jigawa State in its drive to provide an enabling business environment for the economic development of its citizens, has constituted an Ease of Doing Business Steering Committee to oversee the implementation of the objectives of ensuring the ease of doing business in the state;

WHEREAS The Governor of Jigawa State in the exercise of his powers under the Constitution of the Federal republic of Nigeria 1999 and other relevant State laws hereby approves the following waivers and incentives for businesses in Jigawa State;

- \* WAIVER ON BUSINESS PREMISES REGISTRATION: All new businesses of less than Fifty Million Naira investments in Jigawa State shall be entitled to a waiver on business premises registration fees for a period of five years;
- \* WAIVER ON PAYMENT OF GROUND RENT: All businesses of Fifty Million Naira up to One Hundred Million Naira in Jigawa State shall be entitled to a waiver on payment of ground rent for a period of three years;
- \* SUBSIDY ON LAND LEASE: All businesses of One Hundred Million Naira investment and above shall be entitled to a subsidized lease of five years in the first instance and may be renewed on same terms for another five years upon satisfactory compliance with the conditions of the terms of the lease;

- \* WAIVER ON PROCESSING FEES FOR LAND TITLE
  REGISTRATION: All businesses of One Hundred Million Naira and above, in
  Jigawa State, shall be entitled to a waiver on payment of all processing
  fees for land titled registration;
- \* INCENTIVE ON AGRICULTURAL EXTENSION SERVICES: All Agribusinesses in Jigawa State shall be entitled to free agricultural extension services, where available, on demand;
- \* INCENTIVE ON COMMUNITY ENGAGEMENT: All businesses in Jigawa State shall be entitled to free community engagement facilitation with host communities, where available, on demand;
- \* INCENTIVE ON SUBSIDIZED WAREHOUSING FACILITIES: All agribusinesses in Jigawa State shall be entitled to subsidized warehousing facilities for input suppliers and agro dealers where available;
- \* INCENTIVE ON FACILITATION OF LAND COMPENSATION PROCESS: All businesses who acquire land in Jigawa State shall be supported by the relevant MDAs in facilitating the process of their payment of compensation to the host communities;
- \* INCENTIVE ON OUT GROWER SHEMES: Jigawa State Government may provide liaison between large scale agribusinesses and local communities that wish to engage on out grower schemes, in accordance with the Land Acquisition and Resettlement Framework (LARF) in Jigawa State.
